#### Letter to new Health Secretary

by Huijun Shen 27th Sept 2012 给新任卫生大臣的信件 9月27日

- ATCM has worked with HPC and DH closely on preparation of HPC registration for our members through the route of "Register Transfer".
- After 1.5 years of EU Directive, we are running out the TCM products, and this has significantly affected our practice and many of our members have lost large portion of their business.
- Statutory Regulation that allows us to continue our practice has been repeatedly delayed, and further delay should be avoided.
- We also have our concerns over "a single protected title", and we still urge the government to retain TCM title protection.



#### Letter from DH 4th October 2012

#### The Statutory Regulation of Herbal Practitioners

- The legislation is complex as there is an interface both with European law and with medicines legislation and a number of technical issues have arisen
- DH's appreciation that the delay is frustrating and that the current situation is having an impact on the business of herbal practitioners.
- A draft order and a consultation document are being finalised and the Department is continuing to take further advice.

# World Congress of Chinese Medicine (London, 2-3 September 2011) WCCM: Financial issue 世界中医药大会的财务事宜

- The executive host Omega Group is exclusively responsible for the finance of the WCCM, profit or loss
- ATCM did not make any investment into WCCM account
- ATCM made a profit of £16,000 from WCCM, mainly from
  - Charges to co-hosts
  - 20% entitlement on the registration fee of one group of Chinese delegation
  - Large portion of claim on Jessie's workload
  - Part of the claim on paper reading and selection
  - Claim on WCCM Chinese website
- WCCM account was finalised and closed in September 2012 due to a long dispute between ATCM and Omega
- All ATCM personnel working on WCCM got paid for their workload based on WCCM contract

#### A motion by Dr Tian Jun Wang and other 10 members:

- Council members' term on board to be limited for maximum 2 terms
